STANDING ORDERS FOR COUNTY CONVENTION

In order that the proceedings of the Convention are carried out without delay, the following Standing Orders will be observed.

- 1. The proposer of a motion or an amendment thereto, may speak for three minutes, but not more than three minutes
- 2. The number of people entitled to speak and vote shall be in accordance with Rule 3.8 T.O 2023.
- 3. A delegate speaking to a motion/proposal/resolution, or an amendment thereto, must not exceed two minutes.
- 4. The proposer of a motion/proposal/resolution, or amendment, may speak a second time, for two minutes, before a vote is taken, but no other delegate may speak a second time to the same motion or amendment.
- 5. The Chairperson may, at any time he considers a matter has been sufficiently discussed, call on a proposer for a reply and when this is given, a vote must be taken.
- 6. A delegate may with the consent of the Chairperson move "that the motion/proposal/resolution be now put", after which, when the proposer has spoken, a vote must be taken.
- 7. Standing Orders shall not be suspended for the purpose of considering any matter not on the agenda, except by the consent of a majority equal to two-thirds of those present and entitled to vote.
- 8. Delegates who refuse to abide by the Standing Orders will be referred to the Competitions Control Committee.

FINANCIAL STATEMENT

Michael Casey, Byrne Casey & Associates confirmed that the Financial Statement for the 12-month period ended 30th September 2022, gave a true and fair view of the state of the assets, liabilities and financial position of Offaly GAA as at 30th September 2022.

An Cisteoir, Dervill Dolan provided a detailed explanation of all areas of income and expenditure for the year and in particular any major variance between 2021 and 2022 figures. An Cisteoir, thanked everyone involved in Offaly GAA for their contribution to a very strong set of accounts for the year past. The contribution of Christy Todd to the daily management of the accounts was noted.

The Financial Statement was adopted following a proposal from Toni Ryan (Drumcullen), which was seconded by Paul Craven (Kilcormac/Killoughey).

Pat Horan (St. Rynagh's H) withdrew his nomination for Leinster Council Representative and Ciaran Groome (Bracknagh) was deemed elected to the role of Leinster Council Delegate. Joe Higgins was thanked for his years of long service.

On proposal from Des O'Brien (Crinkill) and seconded by Leo Dempsey (Clonbullogue) the following Officers were appointed to attend Annual Congress; Michael Duignan, Colm Cummins, Dervill Dolan & Dolores Slevin.

On proposal from Olly Bryant (Shamrocks) and seconded by Paurig Gallagher (Ballinagar) the following Officers were appointed to attend Leinster Convention; Michael Duignan, Colm Cummins, Dervill Dolan & Brendan Minnock.

CHAIRPERSON'S ADDRESS

Cathaoirleach, Michaél Ó Duigeannáin addressed Convention and commenced by extending thanks to all volunteers, the Management Committee, Sub-Committees, Club Officers, and supporters for their cooperation during the year and highlighted that this was our first in-person Convention in 3 years.

He outlined that the Strategic Plan for the County continues to be implemented and the key pillars of the plan has guided our direction over the last few years. The plan, built around five key pillars, is the driver for much of the positive change being implemented. He referenced the advancements in the area of coaching and games, including the formation of a series of new Club Nurseries in 2022, up to 31 from 7 in 2021. The encouragement of the next generation is key to the survival of all of our clubs. In this regard, he mentioned the changing nature of society and its impact on small rural clubs. He suggested we may need closer examination of these changes into the future. The importance of the integration process with our sister associations was highlighted, he welcomed the appointment of Mary McAleese at National Level to progress the assimilation process.

The growth of the games programme was acknowledged with 552 Adult games and 680 underage games played in the 2022 season. The 43 Offaly Referees were thanked and the Referee Administration Committee was encouraged to continue with recruitment. The increase in activity across all of the schools was highlighted and the importance of the role of the GPO was acknowledged. Retaining focus on the development of the basic skills is key.

The Coaching and Games Committee were thanked for their efforts in relation to the refreshments of policies and procedures around Development Squads. An Cathaoirleach, used his address to announce the appointment of Damien Coleman as the new Offaly GAA Operations Manager. Damien is a very experienced GAA Administrator, and we look forward to working with him.

The importance of Financial Stability was outlined, and the work of the Treasurer and other Officers was acknowledged in delivering a strong financial position for 2022 through sponsorship & ticketing. Whilst acknowledging the support of Carroll's over many years he welcomed Glenisk onboard and acknowledged the ongoing support from Shane Lowry.

In working towards our goal of building Offaly as a Respected Brand, recognised for excellence on and off the field, An Cathaoirleach thanked the Minor Hurlers for their efforts in 2022 and the wonderful journey that they brought us on.

An Cathaoirleach completed his address by thanking and teams and management for their outstanding efforts in 2022. He wished all Offaly teams the very best for 2023. He concluded with a moments silence to remember all of the great Gaels lost in the previous year.

MOTIONS

Bye-Law Motion No.1 submitted by Ballinamere GAA was debated. Pat Cleary (Ballinamere) proposed the motion and it was seconded by Eamon Phelan (Ballyskneagh/Killavilla). Pat outlined the rationale for the motion and how it would work in practice. There was a number of queries from Delegates in relation to the operation of the motion and possible unintended consequence of the motion, particularly on the U20 Championship and the formation of Independent Teams. James Murphy (CCC) highlighted that was concerns over the policing of the Bye Law. An Cathaoirleach stated that many understood the good intentions of the Bye Law but care was needed so as not to create new problems. Pat Cleary (Ballinamere) withdrew the Motion and it will be revisited next year.

Bye-Law Motion No. 2 submitted by Tullamore GAA was withdrawn ahead of Convention.

Bye-Law Motion No. 3 submitted by Edenderry GAA was passed on proposal of Pat Horan (St. Rynagh's H) and seconded by Damien Martin (St. Rynagh's F).

Shinrone GAA were announced at the Club of the Year winners for 2022.

Tullamore GAA were announced at the Underage Club of the Year winners for 2022 and Scór Club of Year 2022.

TUARASCÁIL AN RÚNAÍ 2023

Following a very successful year for Offaly GAA, it gives me great pleasure to present my third annual report as Runaí Chontae Uíbh Fhailí to County Convention. This report is customarily an opportunity to reflect on the themes and events of the previous twelve months and highlight some likely topics for emphasis in the year ahead. A condensed Inter County season brought many challenges for our volunteer Officers, but we look ahead to the 2024 season with optimism with the added support of new full time staff. We aim to replicate the success of the last few years and provide some more great days for the Offaly Faithful.

The report covers three sections, firstly a brief synopsis of the year on the playing fields, secondly a commentary of the key administrative issues and finally some comments on our goals and objectives for 2024.

ON THE FIELD ACTIVITIES

It was an exceptionally condensed and busy year on the playing fields once again. Between the 7 Jan and 17 June, our six Offaly teams played 57 games in 161 days - a game every 2.8 days. April proved to be the busiest month with 20 games played in 30 days. This put a strain on all involved but we expect that the addition of new full-time staff will be a huge assistance in 2024, however the burden of work was eased with the successes on the field. Promotion to Div. 1 of the National League for the Senior Hurlers, a big Championship win at home to Meath for the Senior Footballers and the exploits of the U20 Hurling team were highlights that provided joy to all. In particular, a magical evening in Carlow winning the Leinster U20 Title and chants of 'Uí Fhailghe' at the end of the U20 All-Ireland Final in Thurles will live long in the memory.

Senior Football

Our Senior Footballers season was turned on its head on Sunday 12 March when the shocking news emerged of the sudden passing of Liam Kearns who was in his first year as Offaly Manager. Liam had settled well into the role and was building a great rapport with the players. He was delighted with the response he was getting from the squad and he had a route planned to the Leinster Final. We had performed well in the O'Byrne Cup and recorded a win over Dublin to make the Semi-Finals. Liam was very unhappy with the scheduling of the competition considering our opening league game was just around the corner and many of our players were involved with their respective college teams. We therefore took the unprecedented step of withdrawing from the competition in order to ensure our team could prepare for the opening round of the Allianz National League.

This proved fruitful as we recorded two victories in rounds 1 & 2. This excellent start moved us away from potential relegation worries and allowed the team to concentrate on promotion. Liam's final game was an important victory away to Longford and afterwards he was confident we could be in the promotion shake up.

On behalf of Offaly GAA I wish to acknowledge the mature and respetful response from our Senior Squad around Liam's funeral and within a few days stepping up

to represent the county at a very emotional fixture away to Tipperary. We recorded a fine victory and afterwards

the team attended a dinner in Liam's honour in Semple Stadium. Martin Murphy and his team of selectors should also be commended for the manner in which they stepped up to take the reins.

We entered the final day of the league with an outside chance of promotion but a strong Down outfit took the points in Tullamore. With the Championship only two weeks away it seemed that the emotions of the previous few weeks may have taken its toll on the lads but they regrouped really well and went on a great run in the Leinster Championship.

A hard fought battle away to Longford in the first round set up a home quarter final against Meath. In a blistering opening half, Offaly put Meath to the sword and set up a famous victory in front of an energised home support. The reward for this win was a Leinster Semi-Final against Louth in Croke Park. We played and battled hard against a well prepared Louth team and were only a kick of the ball away from a Leinster Final appearance but ultimately lost out in extra-time and moved to the Tailteann Cup.

Following the highs and excitement of the Leinster Championship we failed to carry the same energy into the Tailteann Cup and exited at home to Wexford after qualifying from our group with a win over London and an away draw with Laois. It was a disappointing end to a season that had such a mix of emotions. However there is huge potential in this group and as we look forward to 2024 and we trust Declan Kelly and his Management team will get the best from them.

U20 Football

After working to provide more games at this age group we looked forward to a round robin format in the Leinster Championship. The positives for the year was players at this age grade were provided with an opportunity to represent their County, however the results did not go as expected.

We secured a late draw against Louth in gale force conditions in the opening round and despite peppering the Wicklow goals at Faithful Fields we came up short and lost by a point. This left an uphill battle against Dublin in the final game and as a result we failed to emerge from the group, which was disappointing given the levels of preparation. Ken Furlong has been retained as Manager for 2024 and as we look toward the coming years we need to use this grade to further develop our players and advance as many as possible to the Senior ranks.

As the league progressed the team grew into itself and began to preform consistently. The fight back to draw with Kildare in the final round of the league seemed to be a turning point as they went on to easily account for Kerry in the semi-final and after a slow start in the final got the upper hand on Kildare to win the Division 2A Title and returned to top flight league hurling for 2024.

An opening win in the Joe McDonagh over favourites Laois was a huge boost as the team went on a run of victories and entered the final round game against Carlow following a total of 11 games unbeaten. With a final berth assured the management team used the final game to rest some players with injury concerns ahead of the final following a very intensive campaign.

The final of the Joe McDonagh, played live on TV was one of the games of the year but this was of little consolation to a team and management that had poured everything into the performance. We were beaten by a point in extra-time and as a finalists were due to play the preliminary quarter final of the Liam McCarthy Cup at home to Tipperary 3 weeks later. Tipp came to Tullamore seeking to get their season back on track and demonstrated little compassion and put Offaly to the sword.

The value of the preliminary quarter final berth to the losing Joe McDonagh team is debatable, however this is to remain part of the Championship structures following confirmation at Special Congress.

U20 Hurling

As Leo O'Connor made the move to U20 Manager, he blooded a few of last years successful minors into the squad. At the outset, hopes were high for further development but this team embarked on an eight game journey that lit up the county once again.

The team travelled through the Tier 2 group in a work-man-like manner and accounted for Kildare in the preliminary quarter final to set up a home game versus a fancied Galway side. A huge performance from a very young team raised expectations that Offaly might have a say in the Leinster Championship. A huge crowd turned out for a mid-week semi-final against Dublin and they were not disappointed with Offaly again performing to a high standard to reach the Leinster Final.

A sell-out crowd at Dr. Cullen Park were treated to an excellent game with young Offaly players excelling and enthralling supporters at the game and live on TV. The provincial silverware was very welcomed and it set up an All-Ireland appearance against Cork in Semple Stadium for the June Bank Holiday weekend. On the day we were over powered by a more physically mature Cork side but Offaly battled well and fought right to the end to display true Offaly fighting spirit.

The confidence with which this group of players played with throughout the Championship engaged a new generation of Offaly supporters.

A Player Centred Approach forms a critical element of our ambition to re-establish Offaly GAA as a renowned county in all codes and in all activities on and off the field. A restructure of our Development Squads was identified as necessary to achieve this goal.

Our revised model for the operation of Development Squads has resulted in a very focussed approach and importantly buy-in from players and parents alike. Our adjustments to our Development Squad model should not be considered in isolation. The growth of our games programme and ongoing working relationship with our schools is a fundamental element of our new structure. Our approach may differ from other counties but we are confident that our tailored approach best serves the needs of our county.

It is critically important to everyone involved in Offaly GAA that every player enjoys their hurling and football but to be selected for an Offaly Development Squad is a significant milestone for any player on his journey of development. We in Offaly GAA want to provide the best

journey possible to ensure that the correct environment is in place to ensure that the player can flourish. It is important to acknowledge the effort of our coaches and players in raising the standards in our squads, along with the support of the parents.

The Faithful Fields forms a critical element of the Development Squad experience. The immeasurable value of cross fertilisation of ideas and relationships among our coaches across all grades should not be under estimated. In addition, players of all ages mixing together builds a sense of community among our players representing our county.

Players and Management

I would like to take this opportunity to sincerely thank all of the Players, Management, Selectors, Back-room Teams and Team Secretaries for their outstanding dedication to the Faithful County. We are immensely proud of the manner in which you represented your County over the last twelve months and look forward to the season ahead.


Club Championships

The CCC led by James Murphy and Christy Todd met over 40 times in 2023 to ensure the smooth running of both adult and under-age games programmes. With the support of a committed team of referees and clubs they delivered an ever expanding programme of games.

Growing and sustaining a vibrant games programme is critical to the development of both codes in Offaly. Our players at adult and under-age level need a consistent games programme that provides opportunities to grow and develop with certainty around scheduling. Much has been achieved in recent years expanding the underage games programme but our adult competitions have contracted in the same period. The changes at national level and introduction of the split season and the demand s of provincial competitions on the other end of the season has resulted in a very narrow window for a dual county like Offaly to deliver a robust games programme. We must work with Leinster Council for ways to tighten up the current games window for provincial competitions to free up more weeks for the counties.

Furthermore, a culture has developed within our own county over many years that once a side exits the championship their season is over. In this regard we are an outlier, as most counties run extensive league programmes that run from March to October and provide the club player with an extensive programme of games. Expanding our adult playing season along the

lines of our under-age games programme will provide more games for our players to develop and also greatly improve the games to training ratio.

Congratulations to all the teams that participated in all Championships and Competitions and particularly to the winners at all levels. Collecting the silverware can make all the efforts worthwhile but there are always runners-up and clubs should be very proud of the levels of participation being achieved in very difficult circumstances. There was a worrying growth in the number of walk-overs in Championship games. Once a rare occurrence, it is something we would like to see reducing in 2024.

At the time of writing our hurling clubs are enjoying very successful runs in the Leinster Club Championships, unfortunately 2023 did not bring any success for our football sides, however, congratulations to all clubs that represented Offaly in these competitions this year.

ADMINISTRATION

In 2023, we returned to a more pre-covid model of holding meetings in person, however we used online methods when required and going forward a hybrid model will probably work best.

This year we continued to build on the significant Governance Audit work completed in 2022. We endeavoured to implement the recommendations of the audit putting procedures in place for the county.

Overall our systems are considered robust and some updated policies will be implemented in early 2024 once further guidance is received from Croke Park. As we move forward, we will continue to improve the administration function and capacity of the County. Our aim is to ease the burden for Club Officers, who give so much to the Association and assist new Officers moving into roles with their clubs.

I would like to take this opportunity to recognise the efforts on the Offaly GAA Management Committee and their work for the County throughout the year. The detailed reports set out in the Sub-Committee Reports section of this document are testament to the hard work carried out in 2023. In particular, I would like to recognise the work of Paddy Scales and Dolores Slevin, who after many years service, complete their respective 5-year terms as Central Council and Leinster Council Representative.

HR & Full Time Appointments

Following an unsuccessful process to appoint an Operations Manager throughout 2022, we worked with HR in Croke Park to backfill the position on a temporary basis by seconding Damien Coleman from Connacht GAA for a 6 month period while we restarted the appointment process. This appointment facilitated a review period, to establish the best resourcing needs for the County.

During this review period, we identified that a part-time Administration Role would be required to successfully support a Head of Operations Role in the County. In this regard, following approval from HR, both positions were advertised at the start of the summer and successfully filled with two very experienced administrators in August 2023, John Hackett - Head of Operations and Carina Carroll - County Administrator.

John and Carina have settled into their roles very well and I believe they will be a critical part in providing stability to the County into the future. They are very experienced and full of enthusiasm for their respective roles. Their energy when combined with an excellent Coaching & Games Staff will lead the County on the journey it needs to travel, guided by elected officers on an annual basis.

A National HR Review and Funding Model for Coaching and Games has resulted in positive change to our Coaching and Games staff also. Michael Cleary resigned his position as Games Manager in April to explore opportunities outside the GAA and we wish Michael well in his endeavours. This coincided with the aforementioned HR Review and Adrian Clancy was appointed as Head of Games Development. Gary Flannery was added as Performance GDA and Nigel Dunne as Games Development Coordinator. These full-time positions will be reinforced by the appointment of further Coaches in the coming weeks. In addition, the above staff are supported by a number Participation Officers formally known as GPO's.

Notwithstanding the recent turnover of staff, we now find ourselves in a very strong position with the personnel at our disposal. There is a very clear vision for the delivery of a high performance programme for the county along with a robust support structure for our clubs. This is paramount to deliver of our core objective of providing a player centred experience in Offaly GAA.

Our team of full-time staff shall ensure the consistent implementation of our Strategy over the coming years. This will provide the consistency in approach to deliver on our goals in a meaningful way and establish our county as a force in both codes once again.

Coaching & Games

Our new Coaching & Games staff model combined with an energised Coaching & Games Committee ensures that the county is continually striving to improve playing standards across the county. Working closely with Coiste na Óg, an expanded and robust games programme has

been delivered and this forms a critical element for the growth and improvement of standards across the county for our young players.

Our reorganised Development Squad model has proven very successful in providing an outlet to nurture elite performance. There is a strong desire among our young players to be involved and this is a credit to the work of Coaching and Games and the coaches involved.

It is worth noting that many Clubs continue to strive towards best practice in relation to Coaching and Games and it was positive to see clubs initiate Nursery Programmes in 2023. Work will continue in 2024 to encourage the best standards in club coaching. We are encouraging clubs to embrace the opportunities offered by the small sided Go Games Programme to enter teams as individual clubs as opposed to Independent Teams.

Go Games Programme 2024

The Club is the basic unit of the Association, and its objective shall be the promotion at local level of the Association's aims, as stated in the Official Guide. In a predominately rural county, where some clubs do and will continue to play as Independent Teams at competitive age grades in order to field teams, the Go Games Model offers the opportunity to foster the sense of club from an early age. In 2024, we are encouraging clubs to field U8 & U10 teams under their own banner, especially as games at U8 can be 5-a-side. If successful, this will provide the further benefit of a more varied games programme within smaller geographic areas. The cornerstone of this strategy is to grow the games, be more inclusive, make the games more accessible whilst optimising fun, friendship, fair-play and enjoyment.

Gaelic Football - Worrying Trends

Across the Association we continue to invest in Coaching & Games and in Offaly we have committed to additional expenditure across all of our teams with a view to improving performance and delivering success for the county and this is being replicated at club level also.

However, as Officers of the County Committee or indeed as an Officer of a Club, we should reflect very carefully on what this increased expenditure is delivering. As custodians of Gaelic Games I believe we have a collective responsibility to protect our games and ensure that they are passed to the next generation in better condition than we received them. Particularly, with regard to the game of football at present, can we honestly claim that our collective investments are improving the quality of the game?

The game of Gaelic Football was based on risk and reward, moving the ball quickly that resulted in a high portion of contested possession among opponents that marked each other tightly which in turn facilitated a spectacle of individual contests throughout the field. The uncertainty and speed of play resulted in a game that was attractive to the spectator and rewarded honesty of endeavour as there was no place for shirking of individual responsibility for players on the field.

Whilst the argument will be made that the game evolves with each generation, I contend we should be very careful not to allow the game to evolve too far from its original principles. The origins of the GAA are based in the fact that we wished to protect our indigenous games from the influences of alien games. At the foundation of the GAA, Archbishop Croke described Hurling and Football as games 'racy of the soil' and forming 'manly exercises' in comparison to imported field sports of the time. I pose the question, are we now importing coaching methods, statistical measures and game plans designed for other games to the overall detriment of our own games.

Tinkering with rules to fix the problems will not work. In the absence of a more principled approach, new methods and strategies will be developed to counteract any proposed rule changes. I believe we must encourage our players and coaches to embrace a return to the fundamental principles of our games. Through our Coaching & Games Strategies we should insist on the promotion of the skills, developing man marking, contested possession and quick play.

Failing to address this will result in patrons voting with their feet, falling attendances and falling revenues. The current levels of investment in our games could not be sustained in that scenario. Already there are trends toward lower attendances at National, Provincial and Club level. Underpinning falling attendances with additional games and competitions shall not solve the problem either. We should not be afraid to call out coaching and negative play that deviates from the original principles of the game and we need to monitor the situation very closely.

Match Ticketing

Over the past couple of seasons we have moved to online ticketing for the vast majority of our fixtures. This has proved extremely successful and I wish to recognise the work of our Finance Committee and our Treasurer's Dervill Dolan and Nessa Feighery for their commitment to the success of the project. In addition, I would like

to thank all the volunteers that operate gates for the County on a regular basis and to the Clubs for their support with the transition to cashless games. Issues in relation to access to ticketing systems, particularly for older generations was acknowledged in 2023 and a Season Pass solution for OAP's was developed that helped alleviate those concerns.

O'Connor Park & Faithful Fields

Throughout 2023, both O'Connor Park and Faithful Fields witnessed huge levels of activity. For the first time in a few years we hosted some big Inter-County fixtures including Kildare GAA fixtures as St. Conleth's park was being redeveloped. The Grounds staff at both locations should be suitably proud of how the grounds were presented at all times.

Sponsorship & Fundraising

In 2023 we expanded our Sponsorship Partnership with Glenisk, when we announced the partnership would extend to the naming rights of O'Connor Park. The deal, when combined with their overall contribution to Offaly, represents a major opportunity to progress Gaelic Games in Offaly. It offers financial stability and the resources to implement our ambitious plans for the future. The sales for the Offaly Jersey carrying the Glenisk logo have been very high to date, with a new design being released ahead of the 2024 season.

We were delighted to welcome Galvins Menswear onto the sleeve of the Offaly Jersey in 2023. This well known and popular brand is an excellent fit with Offaly GAA.

Again, in 2023, Molloy Environmental & the Tullamore Court Hotel provided sponsorship for our Senior Hurling & Football Championships. These are very important partnerships for the County and this year, we were delighted to add EJ Access Solutions as sponsor of our under-age championships.

We are delighted that our continued partnership with Shane Lowry continues to flourish. Shane is a wonderful ambassador for the County and role model for our players. I would like to congratulate Shane on his part in the Ryder Cup win for Europe in 2023.

In addition to our existing generous sponsors we raised monies through the Grand Canal Walk, in conjunction with the Clubs of Offaly. We are very grateful to all our sponsors and to all those people who supported our fundraising initiatives during the year.

We continue to grow our pitch side sponsors at Glenisk

O'Connor Park, with many new partners coming on board in 2023.

I would also like to acknowledge the work and commitment of Club Faithful over many years. Thanks to the Offaly Association in Dublin for their contribution in 2023 through their very successful Golf Classic held to support Offaly GAA.

Club Support

Offaly GAA can only ever be the sum of its parts and in this regard the 41 Clubs of Offaly are important cogs in the machine. Without the army of volunteers in each and every club, the GAA would not exist and would not operate successfully. Every volunteer can be very proud of their contributions.

We look forward to working in partnership with our Clubs and Volunteers in the year ahead to continue the drive toward on-going success for our County. Sustaining high performance for our County teams can only be achieved through the development of our players at Club level. Therefore it is imperative that each Club strives to raise their own standards and the Officers of the County Board are here to assist in this regard.

This year we held a number of engaging meetings with the Senior Officers from each club and these meetings proved very beneficial. We debated issues such as the Age Grades, Go Games Policy and Competition Structures. The debates are robust and honest which is the way things should be. Challenging the way we do things will have long-term benefits for Gaelic Games in Offaly.

I would like to express thanks to the Clubs of Offaly for aligning their respective Financial Year and AGM timetable to meet the requirements of the latest rule changes. Consistency on timing of administration issues like the above will allow us to further streamline administrative processes and improve preparations for the year ahead.

Scór Sinsir

I would like to acknowledge the work of Michelle Hogan and the Cultural Committee and their promotion of Scór. 2023 competitions were held this year and Offaly was well represented in the All Ireland Finals. Birr & Edenderry represented the County with distinction with Birr winning the Rince Foirne.

In Memoriam

As mentioned earlier, Offaly GAA experienced the tragic loss of our Senior Football Manager Liam Kearns. This was a huge shock to all and particularly those that worked closely with him. However in a time of great sadness I was very proud to see how our players showed a maturity and a great sense of decorum around how they represented Offaly GAA at the time of the funeral.

Over the past 12 months Offaly GAA suffered the loss of former County Board Officers, Players and Club Officers. In July, the death of Offaly GAA Life President and former County Board Chairman, Mr Brendan Ward was announced. Although Brendan had lived a long and fruitful life, there was huge sadness at his passing for he had been such a great Gael and ambassador for his county.

Former County Players Sean Brereton (Daingean), Jimmy Dunne (Kilcormac), Donie Hanlon (Gracefield), Pat Heffernan (Tullamore) Donal O'Neill (Edenderry), Ray Horan (St. Rynagh's) and Tom Carroll (Seir Keiran) passed away during the course of the year. The death of Kevin Kilmurray was announced last December and the former player and manager was one of the best footballers of his generation. Former Referee Jimmy Lowry also sadly passed away in February.

Also during 2023, a number of administrative stalwarts, who showed great commitment to Offaly GAA in their roles on various committees, passed away. Most notably Michael Nestor (Clara), Danny Bergin (Killavilla), Joe Parlon (Coolderry) and Eddie Kenny (Edenderry).

Other Gaels worthy of mention are Jim Larkin & Alo Lawlor (Tullamore), and from the steps of the Hogan Stand, one of the most famous Stewards in Croke Park, Johnnie Crosbie (Edenderry).

Everyone above and many others, have made valuable contributions to Offaly GAA during the course of their lives, directly and indirectly through work in their Club. It is therefore, important that we remember them and all club administrators who died in the past year, on the occasion of County Convention.

LOOKING AHEAD - 2024 & BEYOND

The strategy developed for the County in 2020 'The Offaly Way Forward' has served our administration well over the last number of years. The principles of the plan have guided the work of the Management Committee and all of the Sub-Committees operating under the

auspices of Offaly GAA. Striving towards the delivery of the key goals and objectives of the plan has established a solid platform to allow the county to excel over the coming years.

An important element of the consistent implementation relies on the appointment of a dedicated team of full time staff. The experienced and energised group we now have in place will continue the incremental improvement of the county through aligned annual operation plans. This structure is essential to ensure Offaly GAA remains on the pathway to returning to the highest levels of competition. The recent successes of our under-age teams proves that Offaly can dine at the top table once again. We must ensure we are prepared and organised to capitalise on our ambition.

Our ambition in the coming years is to further develop the five pillars of the plan, that will ensure the continued delivery of the goal of an *'Unrivalled GAA Experience'* in County Offaly. The five pillars will be further refined in 2024, as specific projects are identified for implementation.

1. Sustainable Club Coverage

A sustainable network of Clubs providing positive entry points to the Gaelic Games family by maximising participation & provision of excellent facilities

2. Vibrant Games Programme

A defined calendar of games via Club & Schools providing meaningful participation for all levels

3. High Performance Pathway

Provide clear pathway for high performers to excel at County level

4. Financial Stability

Our Clubs and County Board are financially stable with robust governance procedures in place

5. Respected Brand

The Offaly brand is synonymous with success and excellence

On reflection, 2023 was a very positive year on the field of play with all teams back participating with full schedules. The intensity of the split season is very challenging for a dual county and the sheer number of games in a condensed period amplifies the efforts required to maintain a true dual county. We feel those substantial efforts should be very clearly reflected in the funding model allocated nationally to each county and this is an area that we shall be perusing in the coming year. Following recent under-age success in both codes, there can be an expectation that our adult teams should automatically improve. However, patience will be required in order to develop and nurture our emerging talent. There is a body of work to be completed to bring our developing players through and be ready to make an impact at Senior level. Our ambition is to bring ourselves back to the top level in both codes and importantly sustain our position at that level.

The U20 Hurlers were certainly the stand out team of the year and brought us so close to All-Ireland glory once again. Many of these players are under-age again this year and this brings an expectation that we will compete for honours again this year.

Finally I would like to thank everyone who helped me in my role as County Secretary. I have received wonderful support from volunteers across the County, my colleagues on the Management Committee, Leinster Council and from Croke Park full time staff.

The Finance Committee for 2023 comprised Mark Gorman (Chair), Dervill Dolan (Treasurer), Paul Craven, Padraig Egan, Tony Flanagan, Eamon Phelan, Aiden O Neill and Nessa Feighery, (Assistant Treasurer).

The committee was supported by our Operations Manager, John Hackett, and we thank John for all his work and support.

Offaly GAA recorded a surplus of €88,983 for the year ended 30th September, 2023. While this represents a significant reduction on the 2022 surplus of €410,321, it should be noted that the 2022 surplus includes gate income of €288,179 (€241,337 after costs) for the 2021 championship which concluded in December 2021. The 2023 accounts include all gate income for the 2023 championships.

The detailed audited financial statements for 2023 are attached with this report.

Some of the key movements in the financial accounts for 2023 include the following;

- Gross gate income for our 2023 Leagues and Championships was €516,870 compared to €815,243 in 2022. The gate income in the 2022 accounts includes €288,179 arising from the 2021 championship. For comparison purposes, the 2022 gate income was €527,064, resulting in a small decrease in gate receipts in 2023 of €10,194 or 1.93% year on year.
- A new financial structure was introduced in 2023 to support our Games Development and Coaching. The total income from Central Council, Leinster GAA and Club contributions was €347,451, while the total Coaching and Games Development costs were €350,161. This new grant support structure has allowed Offaly GAA and our clubs to significantly increase the number of coaching staff in 2023 to 10 coaches at present.
- The Cúl Camp surplus of €49,085 (2022 -€41,719) represents a significant contribution towards our Coaching and Games Development costs again this year.
- As a result of our Senior Hurlers reaching the Joe McDonagh final, Offaly GAA received a County/ Holiday Grant of €60,000. The Senior Hurling panel and management have requested that Offaly GAA retain this grant towards training costs. We would like to thank the Senior Hurling panel and management team for this kind gesture.
- The County Team Administration costs of €1,160,854 represents a significant expense for Offaly GAA. While the costs this year represent a reduction of €48,480 on last year, we must continue our focus on managing these costs while ensuring we continue to provide quality facilities and good supports for all our teams and development groups.
- The O' Connor Park Income and Expenditure Account reflects a surplus of €24,743 after adjusting for non-cash items.

The Balance Sheet at 30th September 2023 shows an improved position on last year as a result of the surplus for the year with an Accumulated Fund Surplus of €543,006 compared to €454,023 in 2022.

The OCP redevelopment loan balance has reduced by €108,008 from €1,357,071 in September 2022 to €1,249,063 in September 2023.

While the financial position of Offaly GAA has improved significantly in recent years, it is very important that we continue our focus on all our income streams while ensuring that all expenditure is managed efficiently. A continuing strategic approach to investing in our structures and infrastructure with good governance and oversight will help put our Clubs and County in the best position to achieve success into the future.

We are very grateful to all our sponsors and to all the people who supported our fundraising initiatives during the year. The Universe ticketing system is now fully operational for our games and provides greater control and security managing our gate income. Thanks to all our clubs, volunteers and supporters for your continued support throughout the year.

Thanks also to Leinster Council and Central Council for their support throughout the year.

A special word of thanks also to the Offaly GAA Management Committee for all their support. Again this year, members of the Management Committee did not claim honoraria and other expenses this year.

On the field of play, our U20 Hurlers captured the imagination in 2023 following the fantastic success of our Minor Hurlers in 2022 and our U20 Footballers in 2021.

Thanks to everyone involved with our teams, clubs, sponsors, volunteers and supporters who have contributed to our success both on and off the field.

The "Split-Season" has resulted in benefits and obstacles in respect of the delivery of a comprehensive Club Fixture Programme. The "Window" for club championship fixtures is sandwiched between all of Offaly's adult team's exit from the Provincial/All-Ireland series and the commencement of the Provincial Club Championship. Therefore, the options for providing a meaningful club Championship Structure are restricted due to the tight time-scale. The 2023 adult championships proceeded in accordance with the approved Fixture Calendar with the exception of the senior B football championship which concluded later than scheduled due to a successful Club DRA Claim and the U20 championships where there were a number of issues.

The five Adult Football League and four Adult Hurling League Competitions were completed prior to the commencement of the 2023 Club Championship Programme. League Competitions can only proceed without Inter-County panellists. Unfortunately, the absence of Inter-County panellists impacts on the competitiveness and intensity of the League Competitions. Some concerns were expressed with regard to the absence of League promotion and relegation.

The 2023 Adult Championship Programme commenced early in July and concluded before the end of October with the exception of U20 hurling. In 2023, the U20 Championships were organised on a League/Knock

basis, in the interest of providing more games for this Age-Grade. However, the revised structure was not a success. There were seven games conceded (four hurling & three football). There were issues around compliance with the Approved Fixture Plan and concerns were expressed by some Clubs along with adult and U20 Club Team Management members.

There were 15 games conceded in the 2023 Junior B championships (Seven hurling & eight football). Some of these concessions may have been as a result of the long gap between the team entry date and the championship commencement. However, there may be other reasons. Match concessions, and team withdrawals after Championship Groups have been confirmed, are very unfair on the remaining teams in a Championship/ Group.

There were 29 championship match concessions in all adult Grades in 2023. The provision of just three guaranteed fixtures in the league stage of a number of adult football championships was mentioned on a number of occasions during the year.

The Offaly Under-age Games Hurling & Football Programme had an active and comprehensive season with various leagues, competitions & games from March to November. It's unfortunate that 30 games were conceded, but it's still an achievement to ensure that all boys from U8 to Minor had the opportunity to play at least 9 matches in one code or 18 dual matches in 2023. Sincere thanks to host clubs for their contribution to this successful season.

Infractions (Players & Team Officials), Membership, Player Registration and Playing Eligibility issues were all included in Disciplinary Reports prepared by the Competitions Control Committee during 2023. A total of 25% of those Disciplinary Reports were in respect of under-age activity. The current non-compliance with the Guidelines for Governance, Finance, Child Safeguarding and Registration, in respect of Independent Teams, is a cause for concern. Some of these issues were addressed at the recent Adult/Under-age Club Briefing. However, full implementation of the Guidelines for Independent Teams is a matter for the County Committee and relevant Clubs.

A sincere thank you to all referees who officiated at games during 2023. Thanks also to the members of the Referee's Administration Committee, for their work in recruiting and training referees. There were some new additions to the referee's panel in 2023. I appeal to clubs

to support the Referee's Administration Committee in their efforts to recruit additional referees.

The cooperation and support of clubs, players, referees, Sub-Committees and County Committee during 2023 was very much appreciated by the Competitions Control Committee.

Club venues throughout Offaly are of a very high standard and clubs deserve credit for the ongoing developments and improvements. Floodlit venues were in high demand towards the end of the 2023 playing season due to a higher number of postponements than normal as a result of weather/pitch conditions. We appreciate the efforts of clubs in preparing venues to a high standard and request that they strive to maintain a consistent high standard.

In light of the greater demand for match facilities, late in the Club Championship Season, it may be necessary for the County Committee to consider the option of floodlighting O'Connor Park and/or providing a full-size all-weather pitch within the County.

Sincere thanks to all other members of the Competitions Control Committee: Joe Higgins, Dave Coffey, Carina Carroll, Eamonn Dunican, Eamon Phelan, Denis Hoctor, Padraig Keating and Christy Todd.

I would like to acknowledge the contribution of the late Brendan Ward to Offaly GAA. Brendan was a hugely respected figure in Offaly GAA and his term as Chairman of Offaly County Board coincided with a period of huge success for the County.

Finally, on behalf of the Competitions Control Committee, I wish to extend sincere congratulations to the Offaly U20 hurlers on their Provincial success, the senior hurlers on their Allianz League success and all our adult and under-age club championship, league and competition winners.

As per the Treoraí Oifigúil, the function of the Hearings Committee is to "adjudicate on all disciplinary matters where a hearing is prescribed and requested, relating to the enforcement of rules arising from matters under the jurisdiction of the county committee or the executive committee of a club within the county."

The County Hearings Committee does not seek to be seen as a defender of referees, committees or players and assesses the evidence put before it in a fair and impartial manner. Depending on the specific circumstances of each case and the evidence presented, the members of the committee are sometimes left with difficult decisions to make and must strive at all times to be fair and objective in arriving at their decision, while complying with the Treoraí Oifigúil.

In October of this year an additional document, "GAA Codes", was added to the suite of publications relevant to the disciplinary process. The Disciplinary Handbook was also updated. These publications are available on the GAA website and all club officials are urged to familiarise themselves with their contents, as well as the relevant portions of the Official Guides.

An Coiste Éisteachta dealt with twenty-four hearing or appeal requests in 2023. Two hearing requests were withdrawn, two appeals were ruled out of order for non-compliance, one appeal was deemed to have been lost, three cases were referred to the CCC for

re-processing and one disciplinary case involving a supporter was dismissed. Of the remaining fifteen cases, the majority concerned playing infractions, with one red card rescinded and suspensions imposed in all other cases.

It is important to note that the committee is bound by Code 16.1 (aa) (vi), which states "A Referee's Report, including any clarification thereto, shall be presumed to be correct in all factual matters and may only be rebutted where unedited video or other compelling evidence contradicts it" and also Code 16 (bb) which states "An infraction shall be treated as proved if, in the opinion of the Hearings Committee, the infraction alleged is more likely to have occurred than not to have occurred". Without clear video evidence it is very difficult to provide sufficient evidence to overturn a referee's report. Clubs should consider these points in particular and ensure that any member who is considering requesting a Hearing is fully informed and is also aware that they could incur a greater penalty than originally proposed by the CCC. Rule 3.1 (b) states "A Club shall be obliged to obtain a current copy of the Official Guide, and its members shall be deemed to have full knowledge of the Rules and Regulations in it and shall be bound by them."

Where any member or unit is not satisfied with a decision by the Hearings Committee, they have the right of appeal to the Leinster Hearings Committee. Efforts were made to appeal a small number of cases this year, but none progressed as the submissions to Leinster were not in compliance with the Official Guide. Club officials should familiarise themselves with the rules for submitting an appeal and must fully comply with these. It is important to note that a successful appeal hinges on demonstrating that the decision maker infringed or misapplied a rule — it is **not** a re-hearing.

Thank to our referees for clearly stating infractions on reports, club secretaries for their timely and responsive communications, and to all who attended Hearings throughout the year for their courtesy and conduct. Thanks to the members of the CCC who represented their committee at meetings. Finally, thanks to all members of An Coiste Éisteachta for the time and commitment in their efforts to ensure that all Appellants received a fair hearing.

County Team Support

Go Games Days

March saw the commencement of our Senior Inter County league and Offaly GAA encouraged the promotion of clubs playing mini half time games during the adult fixture at home venues our County ground Glenisk O'Connor Park. This proved to be very successful with all clubs across the county getting to play at half time games, many thanks to team managements and players for giving their time to meet teams, get photos and give some encouraging words to our future county stars. Shane Lowry Leagues

September saw the completion of our U12 Shane Lowry Leagues for both Hurling and Football and these were a spectacular occasion for every child at that age in the County. The teams were treated to a full match day experience as they ran out on to the field on our County Grounds, with a team photo and line out for our National Anthem.

These games finished with teams climbing the steps to receive their cup a full match day experience which will hopefully instil in the children the desire to return and compete again and again as they go up the age ranks in their clubs. Thanks to the wonderful work of Mark Forde for capturing these special moments.

Structures

Coiste na nÓg and Coaching & Games are again working tirelessly to prepare structures and plans for 2024 to allow for clubs and parents to plan for the 2024 Season. Our members are working with their Clubs to ensure a satisfactory plan which will provide meaningful competition and maximum participation for Juveniles across the County. We await a final vote on Age Grades for 2024 before we can finalise plans, but it is hoped to have this plan out early in the new year to allow players, parents and clubs the opportunity to plan for the year ahead.

Club of the Year

Club of The Year criteria for 2023 will look at Clubs who participated fully and engaged all their juveniles in games, competitions, tournaments and will also include how Clubs conducted themselves on and off the pitch.

Clubs who are actively engaging their juveniles in Winter Programmes and assisting with the recruitment of young whistlers is also part of the criteria for selection.

Conclusion

Finally, the Coiste na nÓg/Coaching and Games Committee would like to thank Clubs for their continued support throughout the year and for facilitating games and training sessions for teams. It is important also to thank all the Referees and Match Officials who officiated at all Juvenile games across the County during the year and those who gave up their time for the Winter Leagues also. Many thanks to the CCC for their tireless and efficient management of fixtures with over 1000 games a year it is no mean feat to prepare and plan these fixtures, thankfully the weather only played havoc in the minimum number of instances and so everything ran smoothly!

Programmes / Team Sheets

Team sheets were provided for as many adult championship games as was possible in both codes and all league finals throughout 2023. This was also done for all knock-out under-age games in both codes. A lot of work went into preparing national football and hurling league games earlier in the year as we welcomed some big crowds to both O'Connor Park and St. Brendan's Park in Birr. I want to also thank all County team secretaries for their support and efficiency in getting teams in promptly and on time. I would also like to thank Brendan Minnock, Patrick Donegan, Kevin Egan, Kevin Corrigan and Pat Teehan for statistical information for the more in-depth programmes and of course the dedicated programme sellers who turned up every weekend to help.

Coaching & Games - Coiste na nÓg

There was never as much activity on the ground in relation to Coaching & Games in 2023, this comes back to two very hard-working officers who I want to sincerely thank Carina Carroll and Keith Screeney. They have provided details, pictures, and content for our social media platforms all year. Every initiative,

training course, All County Blitzes, Be A Goalkeeper Initiative, All County Nursery, Shane Lowry leagues, Jack Wyer Memorial hurling tournament and Jerry Conway Memorial tournament were heavily promoted. Children's Officer

2023 has been another year of many positives and challenges within Offaly GAA from the Children's Officers' perspective and I would like to start by extending a huge thank you to all those in their clubs who have taken on the role this year. Club officers are to be commended for their continued efforts in ensuring that the guidelines from Croke Park & Offaly GAA are being adhered to and are taking their Child Protection responsibilities seriously, insisting that all who work with our underage players have been vetted, safeguarded, and have received the appropriate level of coaching qualifications.

Again, this year an audit was carried out by Croke Park to assess the risks associated with our underage structures across the country. While these audits can be a little time consuming it served well in highlighting the core areas within our association that need more focus and enables us to provide the best and safest environments for our children, to grow and development their GAA skills at both National & local level.

With all the above taken into consideration Offaly GAA are committed to providing our clubs with all the resources necessary to maintain best practices and standards within our county. It is hoped that in 2024 we will provide even more safeguarding and coaching qualification courses, to meet the needs of clubs. Each year, there are some issues that arise, and all clubs need to be continuously mindful of.

One such issue is that of Respect - abusive language both on the field and towards match officials in our games. All clubs should have a zero-tolerance approach in this area and all team mentors and club committees should be aware of the procedures in place to deal with the issue if it arises. We, the adults, need to lead by example so that our young people see that there is no place for this type of behaviour in our National Games.

The issue of negative side-line behaviour by coaches and onlookers was also raised. In the current climate where Child Protection is paramount and anxiety in young people is becoming all too prevalent this is completely unacceptable. The responsibility lies with clubs to ensure

that the highest standards of behaviour during games are set and maintained, and that players, coaches and supporters are aware of these and lead in this regard, setting good example.

Sport is intended to be primarily fun and as the adults involved, we need to promote a positive side-line culture. "Sport when working with underage players" and the "Guide to Maintaining Appropriate levels of Behaviour in our Work with Children and Young People".

Another major issue of concern in our current climate is the use and misuse of social media in our clubs & games. While there are many great benefits to the use of these platforms in the day to day running of our clubs, it is important to reinforce that - All GAA members, coaches, mentors & players are subject to a code of conduct when online, even when they are not acting on behalf of the GAA. All members are responsible for their own actions and must be aware that those actions may have consequences for the GAA. We all have a responsibility when using social media platforms not to do anything that might tarnish the GAA's image and reputation or bring the GAA into disrepute. It is paramount that all clubs continue to exercise a duty of care, advise and police the guidelines around the use of social media to protect our most vulnerable.

Finally, I would like to commend the Coiste Na nÓg committee for their extensive games planning over the last year, offering huge opportunities to underage football & Hurling across the county. I would like to compliment the clubs in continuing to raise their standards in Child Protection and compliance and trust that this will continue into 2024. I wish all club officers all the best as we approach another new year filled with lots of new challenges and opportunities, while we work hard and continue to serve the young players of Offaly GAA.

Referee Administration

With a total of 43 referee's available to cover over 652 adult Games and 995 Juvenile games from League commencement in mid-March to Championship completion in November, we do owe a huge thank you to this group.

All our games happened over the year without any major incident and a big thank you especially to our umpires for assisting with them. Similar to 2022 we had official linesmen at all rounds from quarterfinal stages to conclusion which happened and for as many senior championship matches as was possible. I would like to acknowledge the clubs who assisted us with linesmen through the year and also to thank the clubs for the facilities at club grounds which have definitely improved throughout 2023 for our refs and his officials.

A clear crisis now facing the Association is the shortage of referees. While there remains a band of outstanding officials operating across the county, it is clear that the numbers are not increasing in line with the number of games now being played at all levels. An increased focus will be required with ongoing recruitment and retention of referees and a zero-tolerance approach to abuse of officials must be adhered to. We have 17 clubs in the county who are not supplying referees, and this has to change throughout 2024.

Indeed, the now seemingly automatic reflex to appeal almost any proposed penalty is most disappointing. Clubs have a responsibility here to discourage those that they must know to be guilty from submitting frivolous appeals and thus undermining the credibility of referees and their reports. We welcome the national initiative by the GAA to focus on the respect for referees, umpires, lines-persons and sideline officials.

To improve standards our committee organised six training sessions in the Faithful Fields throughout 2023 which consisted of physical training, question and answer sessions on knowledge of the rules and detailed video analysis clips on analysis of games in the Offaly championship which led to great debate between the groups. We also held prior to first round of the championship open meetings with club officials and

club managers which was a twofold scenario where the committee outlined the rules and explained what they expected from the players and management with video clips and new guidelines now in place. Club mangers also had the opportunity to outline their views. This was part of a concerted effort to improve standards and to ensure they receive full respect at games.

The Competitions Control Committee and Management Committee were also very supportive during the year. We are very proud that Offaly now have approximately up to 10 referees between Provincial and Leinster panels.

Sincere thanks to all members of the Referee's Committee with Brian Gavin as Chairman, Damian Brazil, Bill Kavanagh, Brendan Troy, and Declan Ward.

Finally on behalf of the Referee's committee, I wish to extend sincere congratulations to the winners of all our competitions

In 2023 The Healthy Club Project concluded Phase 5 with 271 clubs accredited nationally. We are delighted that now 11 Offaly Clubs have achieved accreditation and the HWC committee would like to compliment the clubs who achieved Healthy Club Status Recognition Awards which were presented at the recent Leinster Irish Life GAA Healthy Club Event held in Portlaoise on October 19th.

The following clubs are now accredited as Healthy Clubs: Ballinamere, Ballycommon, Coolderry, Gracefield, Kilcormac/Killoughey, Kilclonfert, Raheen-Foundation Status, Bracknagh, Daingean, Seir Kieran and St Rynaghs Hurling—Silver Status. Other clubs who had participated in the programme were Tubber, Shamrocks St Rynaghs Football.

In 2024 with the next phase of the Healthy Club Programme being planned the County Health and Wellbeing Committee aim to focus on engaging with clubs on how they can become hubs for health information and programmes thereby helping and enabling their members and communities to enjoy healthier and more inclusive lifestyles ensuring a healthier future for everyone. One of the key areas we aim to highlight is how clubs can leverage on and work with partnerships from outside organisations for example Offaly Local Development Company and the HSE.

The GAA Healthy Club Annual Conference took place on Saturday 18th November 2023 and County Health and Wellbeing Committee Forum on Friday 17th. It was good to see several of the Offaly Healthy Club Project participants in attendance.

Special guest speakers where Kerry legend Aidan O'Mahony, former Antrim hurling captain Neil McManus, and Eimear Kelly, Clare camogie star. Dr. Eilis Lawlor presented her key findings of her recent independent evaluation of the Healthy Clubs programme, highlighting the positive impact on participants and on the GAA volunteers who deliver it on behalf of their members and communities.

The County Health and Wellbeing Committee were represented at 3 Leinster Provisional Meetings during 2023 (1 Online) the final one on September 14th at which the meeting was updated on the ongoing work improving the reporting progress and aligning the timelines of the Central Health and Wellbeing Committee annual action plan more closely with the Healthy Club timelines which was welcomed by all parties present.

Finally thank you to all who participated in the Health & Wellbeing structures and supports and to the Offaly County Board for their support during the year. With the easing of the pressures from the impact of COVID we look forward to working directly and engaging with all clubs during a healthier and safer 2024.

We would strongly advise clubs who have not participated in the Healthy Club project to date to apply for inclusion in next phase which will be open to all clubs.

Offaly Handball

It was another good year for the county with plenty of handball action at all levels.

4-Wall

The first competition of 2023 started with our juveniles who competed in the Cumann na mBunscol 4-Wall championships in Carlow. The county was very well represented with eleven children taking part in both the boys and girls U11 and U13 grades. We advanced through some of the preliminary rounds making four quarter finals and two semi-finals. We lost out on a final spot in both the girls U13 doubles and boys U12 doubles by only a few aces.

A few weeks later some of these children took part in the Leinster championships. Our boys competed first with Charlie Mortensen and Issac Mullarkey settling for 2nd and 3rd place in the boys U14 singles. In the U12 singles Keelan Grogan-Barnes and Shane Cummins both had a couple of wins but came up a few aces short to be placed. Hugo Baskakovas put in an outstanding performance in the U13 singles and had to settle for 3rd place on the night.

Our girls were well represented in the U14 singles with Saoirse and Emma O'Meara. Saoirse had a tough battle in her opening round with Hannah O'Reilly of Kilkenny. Saoirse played some great shots, but Hannah was too strong. Emma, who was on the other side of the draw gave a great account of herself and was unlucky to have lost her semi-final to Sophie Farrell of Westmeath in the tie breaker on a score line of 15–11.

Our last young lady to take to the court were Grace Johnston and Alice Murray in the U13 singles. Both girls were very competitive with only a few scores between them throughout the competition. Grace and Alice finished in 2nd and 3rd place respectively with only one point deciding 1st and 2nd place. Westmeath's Emma Finneran won it out on a scoreline of Emma 42, Grace 41, and Alice 34 points.

The Crinkle club was represented with a girls' team at Féile na nGael in Moycullen, Galway last May. The team consisted of Saoirse and Emma O'Meara, Grace and Lily Johnston and Mollie King. It was a fantastic day of handball with the girls getting to compete as a team and to make great memories and new friends from different clubs. We played in Division 3 with the local team Moycullen, Claregalway of Galway, Clogh of Kilkenny, and Liscarroll of Cork. The girls played some very entertaining matches with only a couple of aces between any of the teams. The girls certainly had an enjoyable day and are looking forward to next year's competition.

On the adult scene we had a few mixed results with some of county players making the semifinal stages in the Leinster 4-wall singles and doubles. Our best performer was David Hope in the Masters A where he had to settle for silver against Cork's Brendan Flemming in the All-Ireland final.

Softball

We had a more productive run in the softball with Sian Cooke making the All-Ireland Semifinal where she lost out to the eventual winner Clare Conway of Tyrone. Sian partnered with Christina Donoghue in the junior softball doubles, but they would only make the Leinster

semifinal stage where they were defeated by Wexford. Our male contingent had a mixed bag of results with several final appearances.

The most successful competitors we had were Declan Cooke and Declan Kilmurray in the Golden Master B championship. Both Offaly men contested the Leinster singles final with Kilmurray coming out on top winning it in two straight games, 21–18, 21–12. Kilmurray went on to contest the All-Ireland final against Philip O'Carroll of Cork but lost out on a score line of 21–8, 21–7.

In the provincial doubles campaign, Kilmurray and Cooke teamed up together and won the province very convincingly. The All-Ireland semifinal would see them fixed to play Roscommon in Mullingar. This Offaly duo was far too strong for their opponents and won it, 21-7, 21-16. With a place booked in the final, the Offaly pairing took on last year's runners-up Kevin Buckley and Christy Carey of Tipperary and a hard-fought contest ensued with Offaly coming out winners 21-14, 21-17.

The pairing of Noel Murphy and David Hope advanced to the All-Ireland final in the Master A doubles where the Offaly duo was pitted against a very balanced Tipperary team of John Ferncombe and David Maloney. With the Tipp men having home advantage it proved a little too much for the Offlay duo as they had to settle for silver. Murphy competed in the singles of this competition but was defeated in the All-Ireland semifinal by Ollie Conway of Galway.

Cathal McNamee had a great run in the Junior B singles championship seeing off some tough challenges along the way. He was carrying an injury going in the All-Ireland final against Tipperary's Ned Reilly and it would prove too much of a burden in the end with him losing out 21–21–11, 21–4.

In the softball Irish Nationals Cathal was again defeated in the Men's C doubles where he partnered Stephen Smullen of Kildare. David Hope after his defeat in his opening game of the senior nationals went on to win the Plate competition defeating Diarmuid Mulkerrins of Galway.

1-Wall

Our juveniles kicked off the 1-Wall season in the Leinster championship with some outstanding performances from Fionn Kilmurray, Michael Hosey, Tagh McNamee and Jack Curley. All players gave a great account of themselves with some fantastic wins in the preliminary

and quarter final stages. All 4 players were in hard luck not to have reached the Leinster final in the U12 and U13 singles with the opposition defeating us by as little as one ace in our 4 semifinals.

The Feile na nGael was held in Kilglass, Roscommon and a team consisting of Michael Hosey, Fionn Kilmurray, Ryan McNamee, Jack Curley and Senan Kerrighan of Fahy Cross travelled to take on the best of the country. They saw off tough opposition from, Abbeylara, Longford, Mayobridge, Down and Clann Éireann, Armagh to win out the Boys Division 4. Also, Jack Curley was successful in winning the skills competition.

In the adult grades we were well represented in the provincial championships with Anthony and Cathal McNamee, Anthony, and Declan Kilmurray. Both Anthonys were defeated in the semi finals with Cathal and Declan advancing to their respective finals. Cathal lost the Junior B final to Gary Donoghue of Wicklow by one ace in the tie breaker. Declan won the Golden Masters final against Louth's Ollie O'Connell and was later defeated in the All-Ireland semifinal by Galway's Graham Cashburn.

After yet another busy year we performed very well on the handball stage with plenty of silverware in all three codes. Subsided Equipment Scheme for Schools

MOTION No. 1

EDENDERRY GAA CLUB

- 1. COUNTY CONVENTION (Rules 3.8 to 3.15 T.O.)
 - **1.1.** County Convention, convened in accordance with Rule 3.8, shall elect/appoint Officers and Representatives in accordance with Rule 3.9 and Delegates in accordance with Rule 3.10 following nomination in accordance with Rule 3.11.
 - Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant-Treasurer, Coaching Officer, Officer for Irish Language and Culture, Public Relations Officer and shall appoint a Planning & Training Officer, Demographics Officer and a Children's Officer recommended by the outgoing County Committee.
 - It shall further elect two representatives on Provincial Council and one representative on Central Council.
 - **1.2.** A person nominated for any of the above elected positions shall, 10 days before Convention following a request from the County Secretary, confirm in writing their willingness or otherwise to seek or not seek election.
 - **1.3.** Rule 3.9 (b) (2) shall not apply to the office of Treasurer i.e., five-year limit applies.
 - **1.4.** Before publication of Convention Motions submitted in accordance with Rule **3.12** these shall be examined by the Management Committee. Motions considered out of order should be returned to the submitting Unit indicating reasons and affording an opportunity to re-submit by a date specified in advance of County Convention.

The County Committee shall consist of the Officers elected/appointed pursuant to Bye Law No. 1, the two Provincial Council representatives, and the one Central Council representative, (elected pursuant to Bye Law No. 1 above who shall be ex-officio members), one named delegate from each affiliated club, the County Safety and Facilities Officer, Demographics Officer, County Referees' Administrator, the Coiste na nÓg Chairperson, one named representative each from the County Primary Schools Committee, the County Post Primary Schools Committee and the County Handball Committee and the Head of Operations (without voting rights).
 - **2.2.** In accordance with Rule **3.18** and subject to Rules **3.19** and **4.1** T.O. the County Committee shall appoint the following sub-committees whose powers and functions shall be as detailed therein and, in these Bye Laws where appropriate. The County Secretary shall retain a current list of members of each sub-committee and circulate to the County Committee. The membership of each shall be determined as follows:
 - (i) Management Committee

 It shall consist of the Officers elected/appointed at Annual County Convention, the Coiste na nÓg

Chairperson, representatives to Central and Provincial Council and the Head of Operations Manager (without voting rights).

In accordance with Rule 3.18(i) a recommendation of the County Management Committee on a matter of Finance may not be upset save by a three-fifths majority of members of the County Committee present, entitled to vote and voting.

(ii) Competitions Control Committee

It shall consist of a Chairperson, Secretary and two other members, nominated by the Management Committee for appointment by the County Committee, two named nominees of Coiste na nOg, a named representative of the Finance Committee, one Fixtures Analyst together with the County Referees' Administrator (who shall vote only on the appointment of Referees).

(iii) Fixtures Analysts

As per Rule 3.18 (iii) T.O.

(iv) Hearings Committee

It shall consist of a Chairperson and six other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

(v) Safety and Facilities Committee

It shall have six members including County Safety and Facilities Officer who shall be Chairperson, a Qualified Event Controller. The remaining members, nominated by the Management Committee for appointment by the County Committee, should be suitably qualified in areas relevant to the terms of reference of the Committee as outlined in Rule 3.18 (v) T.O.

(vi) Planning and Training Committee

It shall consist of five members, the Chairperson of which shall be the County Planning and Training Officer. All members shall, upon appointment, complete the necessary training as prescribed by The National Officer Development Committee and Club and County Planning Committee.

(vii) Referees' Administration Committee

It shall consist of the County Referees' Administrator and five other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

(viii) Coaching and Games Development Committee

It shall consist of the County Coaching Officer, as Chairperson, Head of Games Development (who shall act as Secretary), all full-time employed Games Development Coordinators, and four other named members, one of whom shall be the Hurling Coordinator and one of whom shall be the Football Coordinator, nominated by the Management Committee for appointment by the County Committee.

(ix) Cultural Committee

It shall consist of the Officer for Irish Language & Culture, as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

(x) Public Relations/Marketing Committee

It shall consist of the County Public Relations Officer, as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

(xi) Youth Committee

It shall consist of five named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

(xii) Finance Sub-Committee

It shall consist of eight named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

(xiii) Information Technology Committee

It shall consist of the County Public Relations Officer and three other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary) nominated by the Management Committee for appointment by the County Committee.

(xiv) County Teams Management and Panels Sub-Committee

The membership of the County Teams' Management and Panels' Committee shall be as outlined in the Charter for County Committee/Player Relationships and as approved by Árd Chomhairle from time to time and shall be nominated by the Management Committee for appointment by the County Committee.

(xv) Audit & Risk Committee

It shall consist of no more than five named members including a Chairperson nominated by the Management Committee and approved by the Provincial Audit and Risk Committee and up to four members nominated by the Management Committee. The Treasurer shall not be a member.

(xvi) **Demographics Committee**

It shall consist of the County Demographics Officer, who shall act as Chairperson and four other named members (one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

(xvii) Health and Well-Being Committee

It shall consist of the Children's Officer and four other named members (one of whom shall act as Chairperson and one of whom shall act as Secretary), nominated by the Management Committee for appointment by the County Committee.

2.3. In accordance with Rule 3.17 (m) T.O. the County Committee shall appoint the following Sub-Committees whose powers and functions shall be as set out in these Bye Laws.

(i) County Post-Primary Schools Committee

It shall be responsible for the promotion of the aims of Cumann Lúthchleas Gael in all Post-Primary Schools in Offaly through the preservation and promotion of Gaelic Games and pastimes. It shall encourage as wide a participation in Gaelic Games, as is possible. This Committee shall be appointed annually, by the County Committee and shall include a representative of each affiliated Post-Primary School, a representative of the County Coaching and Games Development Committee and an Officer of the County Committee. The County Chairperson shall nominate the Chairperson, for appointment by the County Committee.

(ii) Coiste na nÓg Committee

It shall be responsible for the promotion of underage club activities, for minor grades and below, shall be controlled by a Sub-Committee of the County Committee to be known as Coiste na nÓg.

- (a) Coiste na nOg shall promote underage club activities, for minor grades and below, except where the County Bye Laws provide otherwise. It shall make recommendations to the Competitions Control Committee for arrangements for all Competitions and/or Championships of underage football and hurling up to and including the Minor grade.
- (b) Coiste na nOg shall consist of Chairperson, Vice-Chairperson and Secretary, who shall be appointed at the first meeting of the County Committee each year following a nomination from the Management Committee. One representative from each of Cumann na mBunscol, County Handball Committee, County Camogie Committee (non-voting), County Ladies Football Committee (non-voting) and one representative from each club's underage sub-committee or where clubs combine to form an Independent Underage team one representative from that team (one representative to represent all underage teams up to and including the Minor grade). The Coaching Officer and Children's Officer elected and appointed respectively at County Convention shall act ex officio on Coiste na nOg.
- (c) Coiste na nOg Chairperson, Vice-Chairperson, Secretary, Coaching Officer and Children's Officer shall be responsible for the day to day running of the affairs of Coiste na nOg.
- (d) Coiste na nOg shall meet as required.

3. ATTACHMENT TO FIRST CLUB

3.1. In accordance with Rule 6.3 (c) T.O. a person seeking to become a member of the Association shall be restricted to joining a Club in the Catchment area of his permanent residence or where he has other relevant connection with a particular club as defined by 6.2 (b) (i) T.O. A Club Catchment Area shall be defined as within the Parish and within the County boundary, based on the boundary of the Roman Catholic Parish. If a player wishes to become a member of the Association, by joining a club, outside of the catchment area of his permanent residence, he or the club must submit to the County Secretary, his entitlement to do so.

Exception.

(a) The above definition of Club Catchment applies except where an existing agreement approved by the County Committee is in place.

4. PERMANENT RESIDENCE

4.1. Permanent Residence is defined in Rule 6.2 T.O. with the following exception.

Exception.

(a) To meet the requirement of permanent residence, a player must be residing at his current address for at least 16 weeks. In such cases the onus of proof of new permanent residence shall be on the applicant. Acceptance of proof of residence shall be at the discretion of the Competitions Control Committee.

5. OTHER RELEVANT CONNECTION

5.1. Rule 6.2 T.O. sets out criteria considered to constitute 'Other Relevant Connection' with a particular Club.

6. TRANSFERS

- 6.1. Transfers within the County shall be dealt with in accordance with Rule 6.4 (a) T.O.
- **6.2.** Applications for transfers, within the county, shall be submitted on a duly completed official transfer application form. All Such applications must be submitted to the County Secretary prior to the first meeting of the County Committee each year, which shall be held in January, and no further applications will be considered after that date.
- **6.3.** Such application shall not be granted unless the player is in permanent residence in the Parish in which his new club is located (Regulation No. 43 Catchment Area permitting), is opting for his First Club or has "Other Relevant Connection with a particular Club as defined in sub-section (b) (i) of Rule 6.2. T.O.
- **6.4.** The Competitions Control Committee shall process and make initial decisions on all applications for Transfer and Permission to Play within the county. Such decisions shall reflect the ethos of the Association as outlined in Rule 6.1. T.O. and give due consideration to the negative effect, if any, it may have on the player's First club.

7. CLUB TEAM GRADINGS

- **7.1.** No club may have more than one team at each grade.
- **7.2.** A club that wins any grade of championship shall have that team graded at the next highest level for the following year. A club that loses a relegation final (as outlined in Championship regulations) shall have that team graded at the next lowest level for the following year.

Exceptions.

- (a) If a club that wins a Championship, already has a team in the next highest grade, that team cannot be graded at the next highest level for the following year. In this instance, the team that loses a relegation final, at the next highest grade will not be regraded for that year only.
- (b) If a club loses the relegation final of a particular grade and has a team at the next lower level, no relegation will take place from the higher grade for that year only.
- (c) Clubs entering teams in the Junior A, B or C, Championships may apply to the Competition Control Committee for a change of grade, within Junior level.
- **7.3.** Requests for grading of teams in (c) above shall be accepted by the CCC, not less than 10 days prior to the first County Committee Meeting of the year. No other request for grading shall be accepted. The Competitions Control Committee shall make a recommendation in relation to any such applications to the County Committee. The County Committee retains the right to make the final decision on an application for grading by a Club.

8. PLAYER GRADINGS

- **8.1.** On a date specified by the Competitions Control Committee, a Club may apply to have players regraded by one level, subject to the Club retaining a minimum of fifteen players, approved by the Competitions Control Committee, in each of the required grades, at the Championship status level of the previous year, other than where a Club has been relegated from a Championship.
- **8.2.** A player may not be regraded by more than one level.

Exception.

(a) Players who played on the winning team in Senior B, Intermediate or Junior championship finals shall be considered to be of Senior, Senior B or Intermediate status respectively for

- the following year's championships, unless they have been regraded.
- (b) Clubs impacted by Offaly Bye Law 7.2 (a) & (b) may submit an exceptional player regrading application to the Competitions Control Committee as per Code (10.8).
- **8.3.** In Accordance with Code 10.8 (b) a player aggrieved by a decision on his application for Regrading shall have the right of appeal to the County Hearings Committee whose decision shall be final.

9. AFFILIATION

9.1. In accordance with Code 4.3 (C) entry fee for Championship shall be €80 for each adult team and €8 for each under-age team.

10. INTER COUNTY PLAYERS AVAILABILITY TO CLUBS

In accordance with Rule 6.22 (A) T.O. The period of time during which Senior Inter-County Players shall not be expected to fulfil Inter-Club Championship Fixtures prior to Inter-County Championship Games, in the same Code, shall be as follows 6 days (144 hours) for County Senior, U-20 and Minor Championship knockout games.

11. PLAYING RESTRICTIONS (Rule 6.7 T.O.)

11.1. Subject to the Exceptions hereunder and Bye Law 3.1 Exception (a), the Parish Rule shall be in force for all grades.

Exceptions.

- (a) In accordance with Rule 3.17 (o) and Rule 6.7 T.O., Exception (1) (a) or (b): Where there is no under-age team in a Parish (including Minor & U20), a player in that Parish, may play with an Independent Team within the County which shall not bear the name of an adult Club within the County.
- (b) In accordance with Rule 6.7 (c) T.O. where there is no adult football team in a Parish, a player from a hurling Club, in that Parish, may play with a football team, and vice versa, within the County.
- **11.2.** Applications for Exceptions shall be processed by the County Competitions Control Committee and approved by the County Committee each year. All applications for Exceptions shall, be submitted, on duly completed application forms, to the Committee, by the relevant Club Secretary seven clear days (168 Hours) in advance of the 1st meeting of the County Committee each year.

Exception.

- (a) In exceptional circumstances the Competitions Control Committee may consider an application for an individual under-age player (up to and including U17) during the playing season. Acceptance of such a request shall be at the discretion of the Competitions Control Committee.
- **11.3.** Applications for Independent teams shall only be accepted, on an annual basis, for a team formed in accordance with and complying with the Central Council Policy for the Regulation of Independent Teams.
- **11.4.** If a Club or Independent Team fields an ineligible player, the player and club officials shall be subject to the penalties outlined in the codes and rules of the Official Guide. For the avoidance of doubt the officials concerned shall be the Chairperson and Secretary of each club that forms an Independent Team.

Notes to the Financial Statements for the year ended 30 September 2023

1. General Information

Offaly County Committee is a sports organisation in which the registered office and principal place of operation is O'Connor Park, Arden Road, Tullamore Co. Offaly. The organisation is responsible for the development and oversight of Gaelic games in Offaly.

Statement of Compliance

The entity financial statements have been prepared on a going concern basis and in accordance with accounting standards issued by the Financial Reporting Council. The entity financial statements comply with Financial Reporting Standard 102, the Financial Reporting standard applicable in the UK and the Republic of Ireland (FRS 102).

Currency

The financial statements have been presented in Euro (€) which is also the functional currency of the Association in Ireland.

2. Accounting Policies

Basis of preparation of financial statements:

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates.

It also requires management to exercise judgment in applying the County Board's accounting policies.

Going concern

The entity financial statements have been prepared on a going concern basis. In assessing going concern management has considered budgets and forecasts for the foreseeable future and the impact of severe but plausible downside scenarios. Management is satisfied that the use of the going concern basis is appropriate.

Foreign currency translation

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the financial year end date.

Non-monetary items that are measured at historical cost are translated at the foreign exchange rate ruling at the date of the transaction.

Non-monetary items measured at fair value are translated at the rate of exchange at the date of the valuation.

All foreign exchange differences are taken to the Statement of Income and Retained Earnings.

Government and Other Grants

Grants are accounted under the accruals model as permitted by FRS 102. Government Grants relating to expenditure on tangible fixed assets are credited to the Income and Expenditure Account at the same rate as the depreciation on the assets to which the grant relates.

The deferred element of the grant is included in creditors as deferred income.

Grants of a revenue nature are recognised in the Statement of Comprehensive Income in the same period as the related expenditure.

Notes to the Financial Statements for the year ended 30 September 2023

Revenue recognition

Revenue is derived from gate receipts, Sponsorship, Leinster and Central Council contributions, affiliations fees, entry fees and fundraising activities.

Income is recognised when it is capable of reliable measurement and the principal risks and rewards of ownership have passed to the County Board.

Income from gate receipts and fundraising activities is recognised on the date of the activity. Income from sponsorship, Leinster and Central Council contributions, and affiliation fees are recognised in accordance with the individual agreements.

Financial instruments

The organisation only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares.

Borrowing costs

All borrowing costs are recognised in the income and expenditure account in the year in which they are incurred.

Tangible fixed assets

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses.

Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives.

Depreciation is provided on the following basis: Office Buildings 20% straight line

Equipment 20% reducing balance

New Stand 2% straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in the income and expenditure account.

Debtors

Short term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

Notes to the Financial Statements for the year ended 30 September 2023

Cash

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty. **Creditors**

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

Provisions for liabilities

Provisions are made where an event has taken place that gives the organisation a legal or constructive obligation that probably requires settlement by a transfer of economic benefit, and a reliable estimate can be made of the amount of the obligation.

Provisions are charged as an expense to Income and Expenditure account in the year that the organisation becomes aware of the obligation, and are measured at the best estimate at the Statement of financial position date of the expenditure required to settle the obligation, taking into account relevant risks and uncertainties.

When payments are eventually made, they are charged to the provision carried in the Statement of financial position.

3. Judgement in applying accounting policies and key sources of estimation uncertainty

The officers consider the accounting estimates and assumptions below to be its critical accounting estimates and judgements:

Useful life of tangible fixed assets

Long-lived assets represent a significant portion of total assets. The annual depreciation charge depends primarily on the estimated lives of each type of asset and, in certain circumstances, estimates of residual values.

The Management Committee regularly review these useful lives and change them if necessary to reflect current conditions.

In determining these useful lives the committee members consider physical condition and expected economic utilisation of the assts.

Changes in the useful lives can have a significant impact on the depreciation charge for the financial year.

The net book value of Tangible Fixed Assets subject to depreciation at the financial year end date was €9,037,616 (2022 €9,220,233)

Allowance for impairment of debtors

The County Board estimates the allowance for doubtful trade debtors based on an assessment of specific accounts where the Management Committee has objective evidence comprising default in payment terms or significant financial difficulty that certain customers are unable to meet their financial obligations. In these cases, judgement used is based on the best available facts and circumstances including but not limited to, the length of the relationship.

Accruals

The organisation has accruals recorded in the Statement of Financial Position and this is reviewed monthly by the organisation.

Estimates on the accruals is based on the most reliable evidence at the time the estimates are made. These estimates take into consideration the cost or income directly relating to events occurring subsequent to the reporting date to the extent that such events confirm conditions existing at

the end of the reporting period.

Prepayments

The organisation has prepayments recorded in the Balance Sheet and this is reviewed monthly by the organisation.

Estimates on the prepayments is based on the most reliable evidence at the time the estimates are made.

These estimates take into consideration the cost or income directly relating to events occurring subsequent to the reporting date to the extent that such events confirm conditions existing at the end of the reporting period.

4. Provisions Avaliable for Audit of Small Entities
